

CRIME - MALE EXPOSED HIMSELF RP IS A DELIVERY PERSON FOR JUST EAT, SHE HAS PICKED UP AN ORDER FROM MACDONALDS TO DELIVER TO THE PERSON ORDERING FROM JUST EAT. THE PERSON HAS UNLOCKED THE FLAT ENTRANCE FROM UPSTAIRS AND WHEN THE DELIVERY GIRL REPORTING PERSON, WENT UPSTAIRS TO THE FLAT THE PERSON WAS STANDING AT HIS DOOR WITH HIS GENITALS EXPOSED. [REDACTED] DUE TO OFFICERS SPEAKING TO RP AT [REDACTED] CURRENTLY

THEFT I am calling on behalf of a friend of mine who is a vulnerable adult [REDACTED] [REDACTED] cannot read or write, she relies on everyone else to help her. She noticed this week that all her money in her bank was gone (around £300) so I took her to the bank and the bank advised it had all been spent on UBEREATS recently but gave us no further information. I think it is her friend [REDACTED] as she has access to her card however the bank has now cancelled this. [REDACTED] - TO SAFEGUARD A VULNERABLE ADULT AND TO PREVENT ANY FURTHER CRIMES OCCURRING. ACTION FRAUD UNABLE TO DO THIS.

POA AND THEFT FROM STAFF - INCOHERENT MALE HAS STOLEN A PASTRY AND ATTEMPTED TO STEAL FROM OUR TIP JAR. HE HAS BEEN MAKING EXPLICIT COMMENTS IN THE BAKERY ABOUT WANTING TO PERFORM ORAL SEX ON A FEMALE BUT WAS NOT DIRECTED AT ANYONE, JUST SAYING LOUDLY IN SHOP. HE IS SITTING OUTSIDE THE STORE. DESC - GREY/GREEN THICK COAT, YELLOW SHIRT, CARRYING A LARGE UBER EATS BAGS, [REDACTED] HE IS STILL OUTSIDE THE BAKERY CAUSING A DISTURBANCE, RISK OF ESCALATION [REDACTED] - FOR OFFICERS TO ATTEND, COMMUNITY IMPACT AND ENGAGEMENT

Theft of purse \*\*VVP\*\* My mother has dementia and she was out for a couple of hours in the pub with friends yesterday and someone stole her purse. They have then tried to use her card in shops, but it is not contactless, so they then used it card online about 21 times, ordering Just eat and Vodafone top-ups etc. See log... No immediate risk to victim, who is safe at home. incident happened yesterday. However, she is vulnerable due to dementia. Potential lines of enquiry. [REDACTED] as victim is vulnerable. RP is available today to speak with officers as victim will be unable to speak clearly with them, but will be working tomorrow.

HARASSMENT - RVP I HAVE HAD CHINESE, PIZZA HUT AND UBER EATS AND JUST EATS DELIVERED TO ME TONIGHT - IT IS COMING THROUGH AS WITHHELD NUMBER TO THE DELIVERY COMPANIES - THEY ARE ABOUT £80/£90 FOOD ORDERS - THEY HAVE ALWAYS DIFFERENT NAMES ON THE ORDERS - THEY ARE DELIVERING ANY TIME UP UNTIL 1AM AND THE DELIVERY DRIVERS ARE GETTING INCREASINGLY FRUSTRATED THAT SHE IS NOT THE PERSON WHO HAS ORDERED THE FOOD ONGOING HARASSMENT ISSUES - RP IS HAVING FOOD DELIVERED TO HER HOUSE AND HAS NOT MADE THE ORDERS [REDACTED] - ONGOING HARASSMENT - RP IS HAVING MULTIPLE FOOD DELIVERIES TO HER ADDRESS - RVP
